Mr. Bill Kempling (Parliamentary Secretary to President of the Treasury Board and Minister of State (Finance)): Mr. Speaker, Question No. 92 will be answered today.

Question No. 92-Ms. Hunter:

Has the government allocated any resources toward the development of exportable environmentally friendly technologies and, if so, how much and what percentage of federal government research and development funds does this represent?

Hon. William Charles Winegard (Minister for Science): It is important to draw a distinction between environmental technologies which are specific to improving or protecting our environment and environment friendly technologies which may not relate directly to the environment but the application of which does not injure the environment.

It is very difficult, both in a technical and statistical sense, to separate expenditures into these two categories. This having been said, it is estimated that for the fiscal year 1991/92, the federal government will allocate \$3,287 million to support R and D in general and \$65 million specifically targeted to the environment. The \$65 million represents 2.0 per cent of the total estimated allocation for the support of R and D in 1991/92.

The total grants and contributions paid to businesses by the federal government since 1987–1988 by fiscal year is as follows:

1990-91-\$2,493,222,484

The information is not available for amounts paid to small, medium and large businesses.
