SCARBORO DAIRYMEN GO OUT ON STRIKE

Decide That City Dealers Must Respect a Contract—Inquest at Highland Creek.

WOBURN, Dec. 7.—(Special.)—Splenidid enthusiasm, coupled with downright earnestness, marked an informal meeting of the Scarborough district of the Toronto Milk Producers' Association, held in Kennedy's Hotel here this afternoon.

Every milk route in Scarborough, with a fair representation from York Township, and up the Don-road, was represented, and nothing could exceed the heartiness with which the call to represent the action of certain city dealers by withholding the supply was adopted.

Reports from all parts of the township were received, and show conclusively that Scarborough farmers will stand loyally together until the big city dealers involved in the dispute concede the association rate of \$1.50 a can.

The farmers present, and all the leading ones were represented, frankly expressed their views concerning the present trouble, and openly charged that the city dealers were playing into each other's hands with the well-defined object of breaking up the association.

Incidentally the question of the Toronto Milk Producers' Association embarking in the retail business was introduced, and it was demonstrated by the readiness with which no less a sum than \$4000 was volunteered on the spot that some well-defined plan along this line will be adopted in the near future. The ceaseless wrangle to secure admitted rights was stated by the farmers to be intolerable.

In the meantime the call has gone forth, and this morning, while no general strike has been declared, it is safe to say that the supply of fresh milk coming into the city from the east will be enormously reduced.

How long this condition of affairs will exist is conditional upon the city men interested refusing to complete their contract.

NORTH TORONTO.

Townpeople Pay Last Tribute to Rest of Lay Fred Boudien.

NORTH TORONTO, Dec. 7.—About 10 o'clock this morning a fatal accident happened on Frederick-street, Davisville, at the intersection of the street with E. Wilkinson, T. J. McClelland, 74 years of age, of Sherwood-avenue, was working on the roof when he slipped, falling to the ground and striking his head. Dr. Doherty was summoned, but medical assistance was of no avail, the deceased man never regaining consciousness. Mrs. McClelland was prostrated by the sad news.

Following the arrival of the coroner, the body was removed to the coroner's house and later to his own home. Coroner Bond does not consider an inquest necessary.

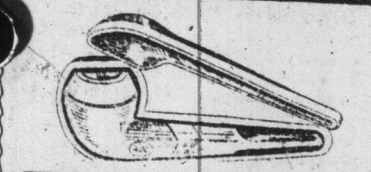
The funeral of the late Frederick Boudien of Sherwood-avenue took place this afternoon from the family residence to St. Clement's Church, and from thence to York Mills Cemetery. The town council, school board, and churchwarden, S.O.E., attended in a body. Rev. T. W. Powell officiated, and was assisted by Rev. A. K. Griffin. The chief mourners were Mrs. Boudien, Arthur and Robert, sons; Misses Winifred, Dorothy and Margaret, daughters; Rev. Dr. C. J. Boudien, president of King's College, Windsor, N.S., brother of deceased. The casket was draped with the Union Jack, the emblem of the S.O.E. Society. The pall-bearers were: Mayor Fisher, representing the town's civic organization; W. J. Douglas, town clerk, representing the civic employees; W. E. Hopkins, principal of the Eglington Public School, representing the teaching staff of the town; Father Grundy and Herbert Waddington, representing St. Clement's congregation; and E. Wilshire, St. Clement's Church choir. The floral offerings were especially beautiful.

At the mass meeting of the town's ratepayers to-night, to discuss the matter of playgrounds, a committee representing all the varied interests, was named to go over the ground. Councillor Parke will be a candidate for municipal honors.

The public schools were closed this afternoon out of respect of the late Fred Boudien.

Eglington Lodge, A.O.U.W., held a pleasant social in their lodge room to-night. Miss Hone Rutledge was the attraction. A fine musical program was given.
