I would like to turn to Sawyer Boats. This outfit received on November 25, 1975, one loan of \$55,000, another on the same day of \$19,800, and a third on the same day of \$25,200. That was over \$99,000 in one day for a company which was, in the opinion of the department, "in a precarious position", and a project that "may well be a candidate for bankruptcy". Mr. Mackie did not consider that that type of funding thrice in one day for a firm already on the verge of bankruptcy unusual.

I turn now to the blatant examples of political patronage at the individual level. I ask why, in the wildest stretch of the imagination, the Department of Indian Affairs and Northern Development would arrange a term loan for Cardinal Family Farms in Alberta for \$113,000 with a repayment of \$1 a year for the first four years, plus simple interest. I ask how an operating loan for \$15,000 under the same terms could be allowed. I ask how it could be done with practically nothing in terms of equity owned by the Cardinal family. The Cardinal family had equity of \$10,000 and received \$153,000.

I also asked about Chief Norman Yellowbird of Alberta. He received \$22,000. He had equity of less than \$2,000. This little story is interesting because one of the conditions of the loan was that Yellowbird dispose of unnecessary equipment, machinery and other vehicles. In spite of this, Yellowbird did not sell his car, and when the second loan was authorized on June 6 the loan contained a condition that the car be sold. Yellowbird traded his car in and purchased a new \$6,000 pick-up truck. Previous to this he already owned three trucks, one of which was a pick-up truck in relatively good condition. The money obtained from this under-the-counter dealing was used as payments on Yellowbird's new truck and a new \$45,000 house. That is political patronage of the worst kind.

Some hon. Members: Shame.

Mr. Brisco: Let no one doubt or challenge my intentions.
