NEW PROVINCE FOR ONTARIO

MOVEMENT TO FEDERATE ALGO-
MA, NIPISSING, THUNDER BAY
AND RAINY RIVER.

FORT FRANCIS, Ont., April 4.—
At a public meeting at Emo last
night, both parties being repre-
sented, a resolution was passed in
favor of the formation of a new
province to include the districts of
Algoma, Nipissing, Thunder Bay
and Rainy River. These districts are
greatly incensed at the treatment of
the Whitney government. On ac-
count of the exceedingly bad roads
in these districts, many of the set-
tlers are pulling out and going to
the Northwest.

LORD AYLMER HAS BEEN RETIRED

WILL PROBABLY BE SUCCEDED
BY COL. VIDAL—RETIREMENT
DATES FROM APRIL 1.

OTTAWA, April 4.—Lord Aylmer,
Inspector General of the Canadian
Militia, has been retired, from April
1.

Lord Aylmer is practically head
of the Canadian militia, standing next
to the Minister, and has earned every
step he has obtained on pure merit.
It is said that he is to be succeeded
by Col. Vidal.

The order retiring Lord Aylmer
was approved by Lord Grey today.
Lord Aylmer in 1893, notwithstanding
that he was a Liberal and that
his brother was a Liberal candidate
for the Dominion Parliament, was
appointed Deputy Adjutant General
of the Conservative Government be-
cause of his special qualification for
the office. In January, 1896, he was
promoted by the Conservative to be
Adjutant General on the retirement
of Col. Powell.

Lord Aylmer is the only Canadian
who filled the office of general of-
ficer commanding. He did so upon
the departure of Lord Dunderland and
was highly praised by the Canadian
press, from Halifax to Vancouver,
for the able way in which he dis-
charged the duties of the office.

When the Militia Council was cre-
ated, Lord Aylmer was made Inspec-
tor General of the Canadian Militia.
He has fearlessly and conscientiously
performed the duties of that office,
criticising what was wrong and ap-
plauding what was right, no matter
who was hit, yet avoiding petty and
carping remarks.

Lord Aylmer is every inch a sol-
dier, and has been the active service
in the Mediterranean. His character
and bearing stamps him as a man for
the fighting line, as well as com-
mand. He is particularly close to
all the officers of the Canadian Mil-
itia from the Atlantic to the Pacific
who, with one accord, will regret his
retirement.

SIR WILFRID DEPARTS FOR METROPOLIS

LEFT OTTAWA AT 3.40 YESTER-
DAY FOR COLONIAL CONFER-
ENCE IN LONDON.

Leadership of House Will Devolve on
Mr. Fielding and the Senior Privy
Councillors—Early Prorogation
Now Among the Probabilities.

OTTAWA, April 4.—Sir Wilfrid
Laurier left for the Colonial Confer-
ence this afternoon with the cheers
of thousands and the ringing of
triumphant songs. He was accom-
panied by Sir Frederick Borden
and the Hon. L. P. Brodeur,
and their private secretaries. They
left Ottawa at 3.40 p.m. for St. John
and Halifax.

To permit the members of parlia-
ment and Senators to see him off the
House of Commons did not meet un-
til 4 o'clock in the afternoon.

There was a great jam of people at
the railway depot. All Parliament
Hill and a large part of the City
turned out to give a hearty send-off
to the Prime Minister and his colleagues.
Those who were able to reach the car
gave him a warm hand shake and
wished him success in the important
mission which he undertakes.

Laurier, Lady Borden, Miss Borden
and Mrs. Brodeur were on the special
and will be passengers on the
Empress of Britain.

OTTAWA, April 4.—A government
council was held this morning before
the meeting of the House of Commons.
It was purely a family gathering to
say good bye to the Prime Minister
and his colleagues, who leave this
afternoon for the colonial conference
in London, England.

The leadership of the House will
devolve upon Mr. Fielding and the
senior privy councillors Sir Richard Car-
wright, will be acting premier. Sir
Wilfrid announced that no contentions
legislation would be pressed and that
the session would likely be brought to
a close about the 20th of the month.
On April 22 Parliament will have been
in session five months.

Among the bills to be held over will
be the Dominion Lands Act, Temple-
man's Proprietary Medicine Bill will

tion which is not absolutely neces-
sary will be held over until the next
session and it is expected that by the
end of the month at the very latest
prorogation will be effected.

will be acting Minister of MILITIA.

BOURASSA'S MOTION OUT OF ORDER

SPEAKER RULED ON GROUND OF
TECHNICALLY AND BUL-
ING CARRIED.

OTTAWA, April 3.—When the or-
ders of the day were called in the
House of Commons today Mr. Bour-
assa presented his motion calling
upon Mr. Fowler to either withdraw
his statements affecting certain mil-
itaries and Members of the House or
to prove them. He said that while his
motion would cover pretty much the
same ground as he had already cov-
ered, still there was sufficient new
matter in it and sufficiently different
from the other to put it within the
order of the House.

Mr. Speaker said that the motion
covered the same ground as the one
put by Mr. Bourassa and that there-
fore he would have to rule it out
of order. He was willing, how-
ever, to hear the views of the House
on the subject.

Mr. Borden said that while he was
not pressed to dispute the ruling,
still he considered it unusual to stop
discussion by a technicality. The res-
olution took a somewhat unusual form
since it pronounced censure on a
Member of the House.

Mr. Bourassa appealed against the
ruling of the chair which was sus-
tained by 194 to 37 against.

When the House resumed at three
o'clock today the Yukon bill in regard
to the appointment of an assistant
commissioner for the Yukon was dis-
cussed.

Col. Sam Hughes said that on the
total gold output there should have
been royalties collected to the amount
of \$7,100,000, whereas the amount
actually collected was only \$3,298,
000. He wished to know the reason
for this.

Mr. Borden and Mr. Foster thought
that an explanation should be forth-
coming as to why the Yukon bill had
been so maladministrated.

Mr. Oliver ridiculed the idea of
maladministration and said that the
Commissioner had not yet been de-
termined.

In answer to Mr. Foster, Mr. Oliver
said that the question of a successor
to the Commissioner had not yet been
decided but it would be before the open-
ing of navigation.

Mr. Oliver said that Mr. McInnes
had, after resigning the Government
post, become legal adviser to the
Commissioner and is now in Ottawa
enjoying a salary of \$7,000.

Mr. Templeman in reply to Mr.
Foster, denied that Mr. McInnes had
been Commissioner of the Yukon
Mines. There was absolutely no
truth in this statement.

The Yukon Placer Mining Act was
passed through committee and read
a third time. The bill was to give power
to amend regulations as to design,
type and all provisions intended to
prevent complicity in the abandoning
and re-staking of claims, with the
object of avoiding payment of roy-
alties.

At present an arrangement
could be made now to abandon a
claim and have it re-staked at once by
another person, the railway com-
pany for using a defective frog. The

PEACE PROSPECTS GROW BRIGHTER

WESTERN RAILWAY EMPLOYEES
AND MANAGERS DRAWING
CLOSER.

CHICAGO, Ill., April 3.—The
prospects of peace between the rail-
road men and their employers have
brightened tonight after another day
of conferences between emissaries
of President Roosevelt and the rail-
way managers. While no common
ground has yet been found, both
sides are drawing closer together.
Chief Garretson, of the employes,
when seen today by reporters said
that while he was not in a position
to make a statement it could be said
that the nine-hour day was the real
stumbling block. It is said that the
companies are considering the grant-
ing of a nine-hour day but such a
step could not be put into effect at
once as it would necessitate the con-
siderable alteration of the train
schedules. If a strike is called on
the nine-hour day only it will not
be so extended as at first stated, as
many of the southern roads are al-
ready run on the shorter day scale.

SPARK CAUSED \$50,000 DAMAGE

AND ENDANGERED LIVES OF
200 TO 600 MEN AT WORK
IN NEW YORK TUNNEL.

NEW YORK, April 3.—Fire caused
by a spark from one of the boiler
rooms in the excavation for the Me-
Adoo tunnel terminal at Dey, Fulton
and Church streets today, did damage
estimated at \$50,000 and a delay of
30 days in the completion of the
work on the huge terminal will be
caused. Five men were injured during
the fire by being caught in one of
the deep caissons, two of them so se-
verely it was necessary to take them
to a hospital.

Deep down under the ground in the
100 or more caissons, which are being
sunk for the foundations of the big
terminal buildings to rest upon, are
between 200 and 600 men at work.
When it was seen that there was dan-
ger of fire spreading to all the
engine houses south of Dey Street,
shutting off the supply of air, the
pressure of which enabled the men to
live underground and the withdrawal
of which would mean serious dan-
ger or death to many of them, the
danger signal was given and the
buckets lowered into the caissons to
bring the tunnel workers to the sur-
face. Around some of the derricks
used to lower and hoist the buckets
the flames raged fiercely and in two
instances the men in charge of don-
key hoisting engines lost their nerve
and deserted their posts, leaving the
men 80 feet below the surface of the
ground to their fate. The deserted
posts were quickly manned by vol-
unteers, however, and the new men
stuck to their posts with the flames
roaring around them until the last
hour of the tunnel workers was
brought to the surface.

OPERATORS AND MINERS DISAGREE

FAIL TO REACH AN UNDER-
STANDING AT THE CAL-
GARY CONFERENCE.

CALGARY, April 3.—The confer-
ence of miners and operators which
has been in session here for some
time came to an end last night when
the convention broke up without
any contracts being signed. The
immediate cause of the split was the
discrimination clause which has
caused a good deal of the trouble
ever since the conferences began.
The delegates have dispersed and ac-
cording to a rumor a strike will
strike is the only thing left. Just
when it will be called or when the
miners will get together to discuss
their failure to reach an agreement
is not known but it is believed that
no time will be lost.

The Canada West Coal and Coke
Company have locked out the men at
Taber and the men were all idle to-
day. President Sherman was wired
that Manager Dixon would not per-
mit the working of the mine unless
a ten hour day prevailed while Leth-
bridge works ten hours a day. Sher-
man wired the men to stand by their
contract and also to Ottawa that he
expects the protection of the new
grades to be immediately granted.
If not granted Sherman will leave for
Taber tomorrow.

OTTAWA, April 3.—The Labor
Department has received informa-
tion from Calgary that Taber mine
is closed. It is a small mine and
another report said that the men were
locked out. The department has
wired the authorities that proceed-
ings for the enforcement of the act
can be taken under part 15 of the
criminal code.
