INCOME TAX

COLLECTION OF SOCIAL DEVELOPMENT TAX BEFORE APPROVAL

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I should like to ask the Minister of Finance whether, in view of the expressed determination of the President of the United States to reduce the burden of taxation on the lower income groups in his country, the minister is reconsidering his unfortunate proposal to increase the burden on the same groups in this country; and in particular, is this perhaps the reason for the delay in his bringing forward the legislation to implement the so-called social development tax?

Hon. E. J. Benson (Minister of Finance): Mr. Speaker, I believe the Leader of the Opposition is talking about the tax reform proposals in the United States being put forward by the President. As the house knows, our tax reform proposals will be presented in the form of a white paper, hopefully by the end of June. With respect to the tax measures contained in the budget, I am hoping to introduce the bill on Tuesday next.

CONSULTATIVE CONFERENCE—DISCUSSIONS AS TO CLAIMS COMMISSION, WESTERN REPRE-SENTATION AND LEGALITY OF TREATIES

Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands): Mr. Speaker, may I direct a question to the Minister of Indian Affairs and Northern Development. In view of the fact that the Indian consultative conference is to begin Monday next, and to be continued until May 5, is it the intention of the minister to divulge to that conference the terms that will be included in any legislation dealing with the establishment of an Indian claims commission, in order that the native Indians who are attending the conference may have an opportunity of discussing this matter?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, I have no intention of limiting the discussion on any subject with the Indians next week. They themselves took the initiative of preparing the agenda, and if they wish to put before me their opinions about the Indian Claims Commisson, I will readily listen to them. But I do not intend to disclose the government's policy in that field, as all its aspects will be known in the weeks following the last conference with the Indians.
