# FARM CREDIT CORPORATION LOANS TO INDIAN FARMERS

## Question No. 2,054-Mr. Gleave:

Of the 48 Farm Credit Corporation Loans to Indian farmers in Canada (a) how many individuals in each province received such loans (b) what was the amount of each loan to each individual (c) what was the purpose for which each loan was made?

Hon. H. A. Olson (Minister of Agriculture): The Farm Credit Corporation advises that: (a) Loans were made as follows: to individual operators, B.C. seven; Alberta, four; Saskatchewan, fifteen; Manitoba, seven; Ontario, three; Quebec, one. To two operators on same farm, Alberta, two; Saskatchewan, one; Manitoba, one. To three operators on same farm, B.C., one; Alberta, two; Ontario, one. In Manitoba, a loan was made to a farm having four operators and to another having five operators. In Alberta, a loan was made to a Band carrying on farming operations. (b) and (c) These matters are considered by the Farm Credit Corporation to be confidential between lender and borrower, whether on or off reserves. However, of the total amount of \$933,700 approved to March 31, 1970, the purposes were as follows: breeding stock, 25 per cent; farm equipment, 22.6 per cent; buildings, 13.2 per cent; other improvements. 3.7 per cent; debt consolidation, 32.6 per cent; miscellaneous, including loan costs, 2.9 per cent.
