PROPOSED WEST COAST TANKER ROUTE—POSITION AND  
NATURE OF DISCUSSIONS

**Hon. Robert L. Stanfield (Leader of the Opposition):** Mr. Speaker, my question is for the Minister of the Environment. Is there anything going on these days between Canada and the United States regarding the proposed tanker route down the west coast from Alaska? The last report was of a meeting of officials and it was indicated they did not have enough information to make any findings. Have there been further consultations or active work undertaken on the part of Canadian ministers or officials of the government on this subject in their relationship with the United States?

**Hon. Jack Davis (Minister of the Environment):** Mr. Speaker, there are no meetings scheduled between ministers. However, studies are continuing on environmental conditions and the impact of oil spills in Puget Sound and Georgia Strait.

**Mr. Stanfield:** What is the nature of these discussions and studies? Are they joint studies that are being made by Canadian officials in association with United States officials, are the studies being made by the United States officials, or are they being made by our officials?

**Mr. Davis:** Mr. Speaker, there are studies on both sides of the line being carried out independently. I would have to add that they are being pushed more energetically on our side of the line than in the U.S.A.

**Mr. Stanfield:** Naturally, I would hope so.

**Mr. Speaker:** Order, please. I will recognize the hon. member for Yukon on a supplementary. We have reached the end of the question period but I will allow two or three additional short questions following the supplementary.

SALMON—ACTION TO INCREASE NUMBER OF RIVER

**Mr. Marshall:** Mr. Speaker, the minister did not answer the question about conservation and the need for extra river guardians this year. What are his intentions in this respect? Last year he had difficulty getting enough funds to provide the required number of guardians.

**Mr. Davis:** Mr. Speaker, we can always do with more river guardians on the east coast.
