INCREASE IN CONSULTATION MECHANISMS—BRIEF OF QUEBEC CHAMBERS OF COMMERCE—
RE-ESTABLISHMENT OF PERMANENT SECRETARIAT

Mr. Roch La Salle (Joliette): Mr. Speaker, I have a question for the Prime Minister.

Last week, at their annual conference, the delegates of the Chambers of Commerce sent Premier Bourassa a resolution asking him to establish mechanisms for consultation with the federal government and Mr. Bourassa replied that he felt it was essential to increase consultation mechanisms with Ottawa—

Mr. Speaker: Order, please. It seems to me that the hon. member could ask his question without such a long preamble.

Mr. La Salle: Mr. Speaker, since the Quebec premier stated that he felt it was essential to increase consultation mechanisms with Ottawa in order to avoid unnecessary tensions within federalism, would the Prime Minister indicate whether he is prepared to favour the establishment of such mechanisms?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, consultation mechanisms already exist and are used a great deal in respect of relations between the federal government and all provinces. I would be prepared, if the Chambers of Commerce are interested, to indicate to them the number of consultation mechanisms already existing. I think the record would show that we have established more of those than any previous government.

Mr. La Salle: Mr. Speaker, I have a supplementary.

The province of Quebec having made known its wishes concerning reopening of constitutional negotiations, is the Prime Minister in a position to indicate whether he intends to re-establish the permanent secretariat responsible for federal-provincial conferences?

**Mr. Trudeau:** Mr. Speaker, the secretariat is still in existence. Only, the staff has been reduced. If the province of Quebec really wants to submit specific proposals with a view to reopening the debate and recalling federal-provincial conferences, we will consider doing so.

Hon. H. A. Olson (Minister of Agriculture): Of course, we can never predict precisely what the weather will be like next winter. Last year there were some unfortunate coincidences involving severe weather, the difficulty of getting cars through certain railroad terminals, and so on. We hope all of these problems can be avoided.
