there have been many instances in which the House has heard ministers announce federal assistance to alleviate or repair flood damage in any cases where the province had so requested. Last year there was a case in British Columbia where the federal government supplied funds to the tune of several millions of dollars. This happens all the time. There is a federal policy. It is important that the provinces and the provincial governments themselves realize the extent of the occurrences.

Mr. Lawrence: Is the Prime Minister then indicating that if the province of Ontario indicated some desire for the federal government to intervene in this matter, in respect of the lower Great Lakes this year, that federal assistance would be forthcoming?

Mr. Specker: Order, please. That question is hypothetical.

REQUEST THAT GOVERNMENT INTERVENE TO PREVENT SUGGESTED INCREASE IN INTEREST RATES BY CHARTERED BANKS

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, I have a question for the Minister of Finance. In view of widespread reports from financial circles that Canadian chartered banks are planning in the near future to raise their interest rate structures, and as, of course, this would greatly slow down industrial expansion and job opportunities, has the minister been in touch with the presidents of these institutions or, if not, will he point out this important fact and request that interest rates not be raised at this important time?

Hon. John N. Turner (Minister of Finance): Mr. Speaker, I will certainly take the representation of the hon. gentleman into consideration.

POSSIBLE ACTION TO HAVE EMPLOYERS LIST ALL AVAILABLE JOBS WITH LOCAL OFFICES

Mr. John Rodriguez (Nickel Belt): Mr. Speaker, I have a question for the Minister and Immigration. In view of the fact that those who are applying for unemployment insurance benefits must first register with local manpower offices, and in view of the fact it was revealed by the Swadron committee report that only 23 per cent of available jobs in Canada are registered with manpower offices across the country, is the minister considering any action to have employers list all jobs available with local manpower offices?

Hon. Robert K. Andras (Minister of Manpower and Immigration): Mr. Speaker, we are not considering any compulsory action, of course, because that would not be in our jurisdiction, nor proper. We are appealing to all employers across this country on every possible occasion to do so. I might say that we have indicated to unemployment insurance claimants that we would prefer that they do not use the services of manpower offices only but to search for jobs beyond that, which is part of the statement I made the other day.
