PROPOSED PAYMENT OF DISCOUNT ON ESSENTIAL PRODUCTS—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

**Mr. Eudore Allard (Rimouski):** Mr. Speaker, under the terms of Standing Order 43, I request unanimous consent of the House to move a motion dealing with an extremely serious matter which calls for the application of emergency measures.

Considering that the price of milk has just gone up from 48 cents to 51 cents a quart, that the cost of butter may also rise by 12 cents before spring, and that those food products are essential to the diet of Canadians and especially that of children, I move, seconded by the hon. member for Villeneuve (Mr. Caouette):

That this House study at the earliest the possibility of adopting a consumer price compensated discount applicable to all food products that are considered essential, in order that Canadians can have access to important foods whose prices are now much too high.

**Mr. Speaker:** The House has heard the hon. member's motion. Pursuant to Standing Order 43, this motion requires the unanimous consent of the House. Is there unanimous consent?

Some hon. Members: Agreed.

**Mr. Speaker:** The question is on the following motion moved by the hon. member for Rimouski (Mr. Allard), seconded by the hon. member for Villeneuve (Mr. Caouette):

That this House study at the earliest the possibility of adopting a consumer price compensated discount applicable to all food products that are considered essential, in order that Canadians can have access to important foods whose prices are now much too high.

Is the motion carried?

In all seriousness, once Your Honour went ahead with the reading, that was the end of the matter.

**Mr. Speaker:** Order, please. Not much can be served by further discussion. I had already asked whether it was the pleasure of the House to adopt the motion, and I believe the hon. member is seeking to explain this motion.

**Mr. Drury:** On a point of order, Mr. Speaker.

**Mr. Speaker:** Order, please. The hon. member for Rimouski (Mr. Allard) quite properly has the floor to speak to a motion put before the House. If there are points of order, I shall be happy to hear them in due course. However, I think we ought to respect the fact that the hon. member for Rimouski has the floor.
