REQUEST TO WITHDRAW TARIFF ON ENGLISH LANGUAGE BOOKS

Mrs. Sheila Finestone (Mount Royal): Mr. Speaker, I hope this is the last time I rise in the House on the subject of the duty on books. Mr. Speaker, I have the honour of presenting a few more petitions regarding this question.

CANADA POST—POSTAL SERVICES

OPPOSITION TO PROPOSED CHANGES TO PATENT ACT
