# ROYAL CANADIAN MOUNTED POLICE

Ms. Lynn Hunter (Saanich—Gulf Islands): Madam Speaker, it is my pleasure and privilege to present a petition, pursuant to Standing Order 36, from a number of my constituents primarily from the town of Sidney which is at the lower end of Vancouver Island in British Columbia.

They are very concerned with the amount of government cutbacks to the RCMP services throughout Canada, particularly about the loss of \$4.1 million for the British Columbia division. This reduction has resulted in the closure of detachments in smaller communities. They are quite fearful that the reduction will extend to
