

Bill C-35, An Act to establish the Department of Citizenship and Immigration and to make consequential amendments to other Acts, not more than one hour shall be allotted to the consideration of the third reading stage of the said bill and, at the expiry of that hour, any proceedings before the House shall be interrupted, if required for the purpose of this Order, and, in turn, every question necessary for the disposal of the third reading stage of the bill shall be put forthwith and successively without further debate or amendment.
