### CRIMINAL CODE

REQUEST FOR REINSTATEMENT OF CAPITAL PUNISHMENT FOR KILLING OF PRISON GUARDS OR POLICE OFFICERS—MOTION UNDER S.O. 43

FIRST MINISTERS' CONFERENCE—GOVERNMENT PROPOSALS TO BOOST ECONOMY TO PROVIDE JOBS—MOTION UNDER S.O. 43

My motion relates to the current economic crisis which is highlighted by statistics showing one million unemployed Canadians, the highest number in Canadian history.
