DISMISSAL OF PARKING LOT ATTENDANTS AT VANCOUVER—MOTION UNDER S.O. 43

ARGENTINA—OBSERVANCE OF BAN ON EXPORT OF CANADIAN PRODUCTS—MOTION UNDER S.O. 43

**Mr. Benno Friesen (Surrey-White Rock-North Delta):** Madam Speaker, on April 12 the cabinet announced its decision to ban the import of all goods of Argentine origin as well as the export to Argentina of those goods and components which could be used as instruments of war. In contradiction of this policy, however, Canada has imported wood products into British Columbia from Argentina by way of a vessel of Argentine registry, the *Entre Rio*, with the shipper on Canadian customs control showing as Nassau, Bahamas, and, further, Canada has exported to Argentina in one shipment alone 400 tons of ammonium nitrate of 90 per cent strength which can be remanufactured as explosives which could be used against the British forces in the south Atlantic. In view of this contradiction of Canada's stated policy, I move, seconded by the hon. member for Pembina (Mr. Elzinga):

That this House call upon the government to enforce its so-called policy of banning Argentine imports and the export of those products of a war capability, including nuclear fuel bundles, because the strength of Canadian support for the British operations in the Falklands is being seriously undermined.

ACKNOWLEDGMENT OF COURAGE OF EZEKIEL AND BENJAMIN HART—MOTION UNDER S.O. 43

Whereas June 5, 1982, will be the 150th anniversary of an act passed in the Legislative Assembly of Lower Canada, granting persons of the Jewish religion all the rights and privileges of other subjects, and particularly the right to hold public office, and whereas the granting of full political rights to Jews did not take place until 1850 in the United States and until 1857 in Great Britain, I move, seconded by the hon. member for Joliette (Mr. La Salle):

That this House recognize the courage of Ezekiel and Benjamin Hart and others who fought for Jewish emancipation and honour the members of the Legislative Assembly of Lower Canada and its Speaker, Louis-Joseph Papineau.
