## QUESTIONS:

1. Question to be put on each paragraph of a motion, 12.
2. Amendment to an amendment, 36, 263.
3. Debate on a question adjourned, 124, 141, 145, 281, 343.—By the Speaker leaving the Chair at 6 o'clock, 88.—By adjournment of the House, 234, 281, 345.
4. Objection taken (at the second reading) that the Bill to capitalize the interest debt, and extend the time for payment of the indebtedness of the County of Perth, is out of order, inasmuch as it affects the public revenue; Mr. Speaker decides that it is out of order, and should have originated in a committee of the whole, 298.
5. Objection taken (at the third reading) to the Bill to enable compensation to be made to the heirs of the late Mrs. McKay, for the erroneous issue of letters patent for lands to which she was entitled,—that it ought to have originated in a committee of the whole; Mr. Speaker decides that the Bill imposed no new burthens, but merely enabled the Government to deal with the case through the 23rd section of the Land Act, 371.

## QUESTIONS NEGATIVED OR SUPERSEDED:

6. To amend the 21st paragraph of the Address in answer to the Speech from the Throne, by substituting one expressing a conviction that no measure for effecting an Union of the British N. American Provinces should be carried into effect, until the people shall have had an opportunity of expressing their approval thereof, 13.
7. For the House to go into committee in reference to free grants of land to actual settlers; Superseded by amendment, 36.
8. That to ensure to those clearing the land every protection, a Homestead Law ought to be adopted, to protect the patrimony of the settler, by exempting it from seizure for debt, up to a certain sum, 87.
9. That (in amendment to the question for going into committee of Ways and Means, to consider certain Resolutions relative to the Tariff, Provincial Notes, &c.) while the House is prepared to make adequate provision for the Public Service, &c., it is inexpedient, on the eve of Confederation, to adopt measures tending to disturb the trade, manufactures, currency, and Banking system of the Province, 124, 132.
10. To re-commit the Resolutions on the Tariff, to amend the same by transferring Factory Machinery from the free list to the 15 per cent. list, 183.
