MR. DAVIS ON THE STAND

Denies That He Tried to In- fluence Mrs. Bulkholder.

Evidence for Defense in Long- Drawn-Out Will Case.

Adjournment Until Saturday—Saubny Case Postponed—The School Board vs. Council Action.

The case for the plaintiffs in the Taylor-Davis will case at the non-jury sittings having been concluded when the court rose for luncheon yesterday, the defense was proceeded with immediately upon Mr. Justice Meredith's resuming the bench.

Mr. M. H. Howland, manager of the Canadian Savings and Loan Company; Mr. John S. Moore, accountant of the Huron and Erie, and Mr. C. W. Wood, burne, teller of the London Loan, gave evidence relating to the visits paid by Mrs. Bulkholder to transact business matters, and each witness said he noticed nothing in her actions to indicate a weakness in her mental faculties.

Four medical men were next called to testify as to Mrs. Bulkholder's mental condition. Dr. George Wilson and Dr. Eccles had both attended the deceased. Dr. Eccles was her medical adviser from 1891 to 1896, treating her for stomach trouble. Mrs. Bulkholder complained once or twice of dimness of vision and dizziness. Dr. Eccles found her a very intelligent woman and a little cross. Mr. Meredith asked Dr. Eccles his opinion of Mrs. Bulkholder losing her way. The witness said that persons fix points to enable them to find their way home, and if Mrs. Bulkholder failed to fix the points she was losing her way.

Was there anything in her actions to indicate that Mrs. Bulkholder was having delusions? "Nothing that I noticed while I was attending her."

"Or anything you heard in court?" "Except one witness, who said Mrs. Bulkholder expressed a fear that she was going to be robbed or murdered. That would be a delusion, he noticed."

Dr. Waugh, a professor in the Western University who had heard the statements of all but two of the witnesses did not consider there was anything in the evidence to indicate delusions on the part of Mrs. Bulkholder.

"What about her being unable to find her way?" "Is it common or uncommon?" "Common."

"Would that have any effect upon her other mental faculties?" "The evidence of Dr. J. M. Piper, of South London, was distinctly favorable to the plaintiffs. Dr. Piper attended Mrs. Bulkholder several times before her death. He was called to the house on June 1 and Aug. 20, 1896—the date of her death. She was suffering from stomach and liver trouble. The witness saw her on May 2, the day the last will was drawn up. She was in a short time in the evening, and get up and dress, thinking it was morning. Dr. Piper was of the opinion that the old lady was insane. In July and August she was unable to understand anything that was said to her. There was no question in his mind but that she was insane and incapable of transacting any business."

James Murray, who purchased some property from Mrs. Bulkholder in 1892, told of the close bargain driven by the old lady.

Archdeacon Davis, the principal deponent next to the state. He made a sweeping denial of all charges of undue influence made against him by the plaintiffs. Mr. Davis became acquainted with Mrs. Bulkholder in 1880, and she was his spiritual adviser. With the exception of the time she resided on Queen's avenue, she was a regular attendant at St. James' Church. He never transacted any of her business affairs with reference to the placing of the memorial window in the church. It was only after some hesitation that she agreed to have the window placed in the edifice. The witness denied ever having received any money from Mrs. Bulkholder.

"It is said you wanted her to give \$2,000 to two of your children." "It is positively false."

"It is said you told her it would be just the same as a mission work." "I never said so."

"Did you ever suggest to her that she should give any of her money to yourself or members of your family?" "Never."

"Nor that she should not provide for her relatives?" "Never. On the contrary, I urged her to get some of her relatives to come and live with her, so that they would have a great relief to me."

The witness said he never attempted to prevent Mrs. Bulkholder from doing as she pleased in all matters. It was true that he had refused to sign a statement that she would have any money left if she gave away what she desired to. The only suggestion he made to her was that in making her will she should make provision for her own proper care and nursing. He never attempted to induce her to change her intentions regarding the disposition of her money.

Archdeacon Davis denied having called on Mrs. Bulkholder more than twice while she was living with Mr. and Mrs. Smith. He had made no distinction whatever between Mrs. Bulkholder and other members of the congregation with regard to the frequency of his visits. In 1893, the year of her death, the witness called on Mrs. Bulkholder, eleven times—twice in May and June, and once in every other month up to September. He had nothing to do with the sale of the Elmwood avenue property in 1892; neither did he know the contents of the will of May 3, 1896, by which the estate was left to his four children, until a week after Mrs. Bulkholder's death. He understood the deceased had some relatives, but he did not know the names or addresses of any of them until he was making arrangements for the funeral. Mr. Smith promised to give him the names of the relatives in order that he could notify them of the funeral, but failed to do so. The witness did not look after the graves of Mrs. Bulkholder.

The statement that he told Mrs. Bulkholder not to keep money about her because she might be robbed was untrue. He went to Mr. Fisher, the direction of Mrs. Bulkholder, and told him she was wanted to draw up her will. Mrs. Bulkholder repeatedly desired to leave her money to Mr. Davis, to which the latter objected. Witness told Mr. Fisher that he objected to any such action on the part of the deceased, and he also declined to take Mrs. Bulkholder to Mr. Fisher, because of her desire to leave the property to him.

Mr. Aylesworth's cross-examination of Mr. Davis was a lengthy and severe one, but the witness's evidence was unshaken. He said he considered Mrs. Bulkholder a very devoted woman, and he knew she was not in need. He believed she had made a will in 1896, but he was not aware that he was named as an executor. He considered it a duty for a year and a half before her death. Mrs. Bulkholder was able to go to Mr. Fisher's office unaided, and he declined to take her because she had been talking of leaving her estate to him.

"You were quite content that she should leave it to your children?" continued Mr. Aylesworth.

"I was."

"Was her leaving it to them the outcome of her refusal to accept it personally?" "At first I made no objection to the property being left to the children, except that I urged her to make provision for herself in her old age."

Mrs. Bulkholder and Mr. Fisher were not told the names of the four children by the witness. They were Llewellyn, Llanarth, William, Gwen. The witness said he expected the children to be named in the will. Mr. Robinson and his four children would benefit under the will. He never heard Mrs. Bulkholder say she was afraid her nephew, Dr. Payne, would poison her. He heard her say some of her relatives had either wronged or robbed her.

To Mr. Cronyn, the witness said Mrs. Bulkholder refused to act on his suggestion to have some relatives come and live with her, as they had wronged or robbed her. He did not notice any signs of insanity on the part of the deceased either before or after the will was made. There was nothing more than a weakness of memory. She was thoroughly competent to transact business.

Rev. Canon Richardson, the next witness, having been the rector of the Memorial Church while she attended the services there, said he saw nothing to lead him to believe that she was not mentally sound. In March, 1892, Mr. Richardson advised her speak of having made a will.

Fred Pope, who lived at Mrs. Robinson's while Mrs. Bulkholder boarded there, testified that he never noticed anything strange in the actions of the deceased.

Sarah E. Keffer, of Toronto, a niece of Mrs. Bulkholder, produced correspondence to show that she was on good terms with her aunt. In one letter written in 1895, the old lady asked Mrs. Keffer if she would accept her household effects in the event of her death, as well as some money.

On October the court adjourned until Saturday, when the case will be resumed. Mr. Justice Meredith goes to Chatham to take a court there today.
