Entry Into force of the Tax Agreement

Between Canada and the Republic of Zimbabwe

December 21, 1994

Finance Minister Paul Martin announced that the agreement for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income, capital and capital gains between Canada and the Republic of Zimbabwe, signed at Harare on April 16, 1992, came into force on December 15, 1994, the date on which instruments of ratification were exchanged in Ottawa. In accordance with the provision of Article 30 of the Agreement, its provision will have effect in Canada: a) in respect of tax withheld at the source on amounts paid or credited to non-residents on or after the first day of January 1995; and b) in respect of other Canadian tax for taxation years beginning on or after the first day of January 1995.
