INTERNED ALIENS-DEPORTATION AFTER THE WAR

Mr. ROY:

1. Were aliens in Canada who have been interned during the present war permitted to retain possession of their property?

2. Will they be subject to deportation on the cessation of hostilities or shall we allow to remain in Canada members of the fifth column who have been or shall be interned for the duration of the war?

Mr. CASGRAIN:

1. Under the consolidated regulations respecting trading with the enemy, 1939, the definition of "enemy" includes "any person who has been detained under the defence of Canada regulations during the period of such detention". The property, therefore, of any such person for the period of detention is vested in the custodian of enemy property.

2. Information is not available as to the number of interned persons who may be subject to deportation under the immigration laws as they stand at present. This inquiry raises a question of government policy which, obviously, cannot be settled until the termination of hostilities.

CANADIAN ARMY—ENLISTED MEN PAID AS TRADESMEN

Mr. WINKLER:

1. Are any of the enlisted men in the C.A.S.F. receiving pay as tradesmen, such as carpenters and so forth?

2. Did recruiting officers receive authority to offer the going pay as tradesmen in order to induce men to enlist?

Mr. RALSTON:

1. The financial regulations and instructions for the Canadian active service force on active service provide that warrant officers, non-commissioned officers and men employed as tradesmen in capacities and under such limitations and conditions as are authorized by the minister, shall, if qualified and approved by the officer commanding the unit to which they belong, be entitled to receive tradesmen's rates of pay.
