GREY CUP BROADCAST-LEGAL RULING

Motion No. 42-Mr. Chevrier:

Mr. Halpenny: Mr. Speaker, legal opinions are privileged communications and are not normally produced. However, in view of the fact that in this instance the C.B.C. has itself made public part of the opinion given it by the Department of Justice, therefore the tabling of the legal opinion from the Department of Justice in this instance would not constitute a precedent for the tabling of legal opinions provided to government departments and agencies. Therefore the government is prepared to accept the motion in this instance. This action is based on the particular circumstances, and is not to be regarded as a precedent.
