DELAY IN ISSUING RETROACTIVE PAY CHEQUES

eral happy this weekend. Has the President of the Treasury Board received a lawyer's letter about the delay in payment of retroactive wages to civil servants, and what action does he plan to relieve the hardship to many people?

Hon. C. M. Drury (President of the Treasury Board): Mr. Speaker, I did receive a letter from the legal representative of the Professional Institute of the Public Service. It has been forwarded to the law officers of the Crown for advice. I should point out that we have been taking and are continuing to take massive action to try to overcome the very large problem created by this backlog of retroactive pay. As I indicated to the House before, in each individual case of reconciliation of accounts going back to July 1, 1967 there is a great deal of clerical work required in the departments and in the Central Pay Office. It is this complicated one-time operation we are trying to get over.

Mr. Bell: May I ask the President of the Treasury Board what he thinks of a meeting on this matter with the legal officer such as has been suggested?

PLACING OF SERVICEMEN'S GROUP INSURANCE WITH U.S. ACQUIRED CANADIAN COMPANY
