I do not know if they will be successful. I do not think it would add any strength to the union to paralyze, for example, the ferries to Prince Edward Island. I hope they will reach some kind of an agreement with regard to those who are in a very special situation.

# WOMEN'S PRISON, KINGSTON—REASON FOR DELAY IN CLOSING

Mr. John Gilbert (Broadview): Mr. Speaker, my question is directed to the Solicitor General. Almost three years ago the Report on the Status of Women recommended the closing of the women's prison at Kingston, Ontario. A few weeks ago, the minister said his officials were consulting with provincial officials regarding this matter. Will the minister tell us when the closing will take place and the reason for the delay?

Hon. Warren Allmand (Solicitor General): Mr. Speaker, we have been discussing this matter with the provincial attorneys general. It has been agreed to put the subject matter on the agenda of the Federal-Provincial Conference on Corrections which will take place in early November.

#### WILLIAM HEAD—REASON FOR CONVERSION TO MEDIUM SECURITY INSTITUTION BEFORE HEARING REPRESENTATIONS FROM LOCAL CITIZENS

**Mr. Donald Munro (Esquimalt-Saanich):** Mr. Speaker, my question is also addressed to the Solicitor General, but is in no way to be considered supplementary. On May 23, as recorded at page 4019 of *Hansard*, the Solicitor General gave an undertaking to the people near the William Head Prison that this institution would not be converted to a medium security prison until the representations and proposals of the community had been considered. Will the minister tell the House why residents of the area have now been advised by the minister that William Head is to become a medium security institution?

Hon. Warren Allmand (Solicitor General): Mr. Speaker, we did take the representations of the citizens seriously. They were examined by myself and officials of my department. We found we could not delay the implementation of medium security status at William Head. The representations were fully considered. I recently wrote a letter to the President of the Ratepayers' Association of Metchosin informing him we would have to go ahead with the plans for medium security status at William Head because we had a serious overcrowding problem and were not able to find other places for our prisoners at the present time.

**Mr. Munro (Esquimalt-Saanich):** It is my information that the citizens have not yet submitted—

**Mr. Speaker:** Order, please. Perhaps the hon. member might ask his supplementary.

**Mr. Munro (Esquimalt-Saanich):** Is the minister prepared to release to me what he calls representations made by the citizens of the community, because I understand they have not fully submitted representations with regard to their problems?
