### MR. RIIS—VIOLENCE IN AMRITSAR, INDIA

**Mr. Nelson A. Riis (Kamloops-Shuswap):** Mr. Speaker, it is my pleasure to present on behalf of the majority of Sikh constituents in the constituency of Kamloops-Shuswap a peti-

tion bringing to the attention of the House of Commons the profound tragedy that has been inflicted upon a small minority of the people of India. The petition wishes to draw to the attention of Members of the House of Commons the brutality and violence which has been perpetrated against the holy Temple Amritsar which is presently lying in ruins. They ask for a stay of deportation proceedings for the Sikhs presently within Canada and urge that the International Committee of the Red Cross be given all the necessary support by the Government of Canada to bring aid and relief to those suffering as a result of the violence in the Punjab.
