In his Lenten address at St. James' Cath-
edral yesterday, Bishop Sullivan treated of
"Verbal Inspiration." The question was

it is directly due to certain believers who
are their mistaken zeal in interpreting the

Book, but in reality they have nothing
to do with the composition, and they were
no more agents than the pen or
the electric wire."

its passage.

To Rebuild the Bridge.

rebuilding of a bridge over the canal on the
4th concession. P. had been washed away
some years ago. The structure
will cost in the neighborhood of \$1000 and
the Engineer will supply a report before
any further steps are taken in the matter.

To Amend the Bylaws.

disposal of a grant of \$200 passed some
time ago for the removal of the canal con-
cession. The applicants were assured that

would be repaid as soon as the water permitted.

Alleged Railway Interference.

T. Crawford, Clerk of Scarborough, asking
York's co-operation in fighting the
cause of a bridge which had been placed
on the town line. Engineer Gibson said
he had been placed at the complaint and
thought it might be the source of accidents.
The Engineer's office considered it inadvisable
to enter into litigation, but will ask the
applicant to notify the railway of his ob-
jection, and that the company will be held
responsible for any damage occurring.

East Toronto and the G. T. R.

tors for East Toronto, asked for a copy of
an agreement entered into between the
Metropolitan Railway and the G. T. R. re the
closing of Davis-road and the maintenance
of bridge over Main-street in East Toronto.
On payment of the costs of copying, the
smaller corporation will be accommodated
with the document.

Alleged Obstruction at York Mills.
A request was made by the solicitors of
the Metropolitan Railway and the York
County Commissioners for the passage of a
bylaw, compelling the removal of the ob-
struction placed by Mr. C. R. R. in the
Don at York Mills in order that a wash-
out of the abutments of the bridge might
be prevented. The Council refused to en-
force the proposition, the general feeling
being that the Council had no right to
interfere with the property of a private
individual.
