

HUNDREDS SIGN NOMINATION PAPERS OF A. F. BENTLEY

Names of Some of Those Who Will Work for Success of Opposition Candidate in the County.

The proceedings at the court house yesterday when candidates were nominated to contest the vacant seat for the legislature for St. John county, caused by the elevation of Hon. H. A. McKenna to the supreme court bench, were very quiet. The two candidates whose names have been before the people for some time—A. F. Bentley and J. P. Mosher, were the only nominees, and an arranged beforehand there was no speechmaking. High Sheriff R. R. Ritchie opened his court at 10 o'clock, and was sworn in by Charles F. Sanford, a justice of the peace. He then read the election proclamation, as required by law, although Mr. Sanford composed the entire audience. The first papers filed were Mr. Bentley's, the Liberal candidate, at 10:30 o'clock and shortly after Mr. Mosher's papers were presented, each nomination being accompanied by the payment of \$100 in legal tender, as the law provides. The court was open from 10 to 2 o'clock for the receipt of nominations and from 12 until 2 p. m. for any objections that might be raised. The election proclamation provides for the polls to be open from 8 a. m. until 4 p. m. or in case of delay in opening, for a full 3 hours. J. W. V. Layton demanded a poll, which was granted by the sheriff to be held on Tuesday, July 20, as announced in the proclamation. He thereupon adjourned the court until Friday the 23rd inst., when the result of the balloting will be declared.

THE RHODES-CURRY STOCK FLOTATION

Nearly \$3,000,000 of Common and Preferred Stock Will Be Issued—Much Interest in It. Montreal, July 13.—Interest is being taken around the "street" in the Rhodes-Curry flotation which is being handled by C. Meredith & Co., Ltd., and the Royal Securities Company. It is understood that the seven per cent cumulative preferred stock will be given to the public at \$2 1/2 with a bonus of twenty per cent common stock. As the company earned no less than seventeen per cent on the common stock last year, the public subscriptions were exceptionally large and it is expected that the issue will be largely over subscribed. The issue of preferred stock amounts, it is said, to \$1,800,000 and common \$1,000,000. It is thought that the common stock at the outset will sell around thirty to forty.

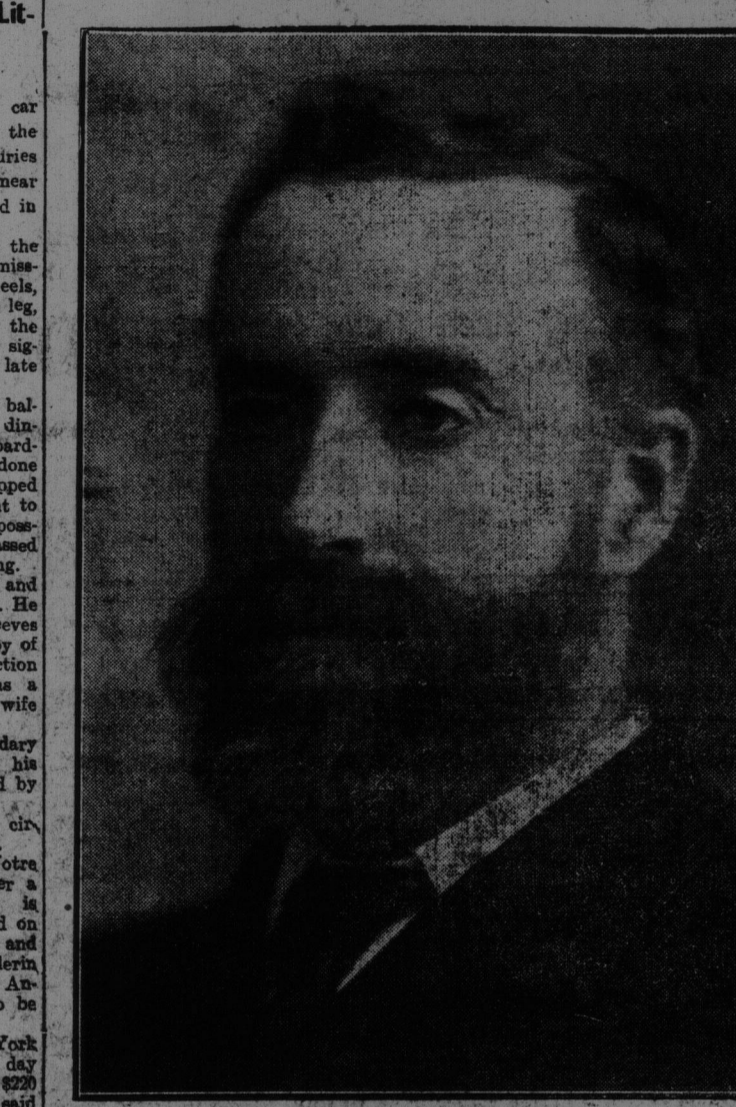
GRANDSTAND FELL; ONE MAN MAY DIE

W. S. Garrison Had a Broken Leg and Was Internally Injured at Summerside. Charlottetown, P. E. I., July 13.—Shortly after the "Big London Show" opened up in the skating rink at Summerside last night, the grand stand gave away and about 800 persons were precipitated to the floor and a number of persons were slightly injured, but for the most part escaped serious injuries. Amongst the number was W. S. Garrison, a well known fruit agent, who did not fare so well, as he received a broken leg and today it is not expected he will survive the accident, which seems to have caused his internal injuries.

ENGINE CUT OFF ARMS AND A LEG

Walter Steeves, a G. T. P. Car Inspector, Fell and Was Literally Cut to Pieces. Moncton, July 13.—Walter Steeves, car inspector with Corbett & Flesch on the G. T. P. construction, sustained injuries by falling beneath a gravel train near Salisbury at noon today which resulted in death a few hours later. The young man attempted to board the engine as the train was moving. He missed his footing and fell under the wheels, which passed over both arms and one leg, crushing them badly. A brother of the young man saw him fall and at once signalled to stop the train, but was too late to avert the catastrophe. The accident occurred just as the gravel train started immediately after dinner. Following the usual custom of boarding the engine—something he had done hundreds of times before—Steeves slipped and fell to his death. He was brought to Moncton on the engine as quickly as possible and taken to the hospital but passed away shortly after 7 o'clock this evening. Deceased was thirty years of age and had been married about four months. He was a son of Gilbert Steeves, Steeves Mountain, and had been in the employ of Corbett & Flesch since the construction work started. The sad accident was a terrible shock to the deceased's young wife who is prostrated with grief. The body will be taken to Boundary Creek tomorrow for burial. Besides his wife and parents deceased is survived by two brothers and four sisters. Coronar Rose is inquiring into the circumstances of the young man's death. There is much excitement at Notre Dame, Kent county, and vicinity over a reported gold discovery recently. It is stated that rich gold quartz was found on the bank of the creek at St. Anthony and later more quartz was found at Pelletier Settlement, a short distance from St. Anthony, and both finds are believed to be on some vein. Samples of ore were sent to New York and it is said the report received a day or two ago shows the quartz assayed \$200 to the ton. A man named Grogan is said to be at the head of the party making the find and a mining lease has been taken out from the crown land office, Fredericton.

STRANDED TROUPE HOME TO NEW YORK ON A BANANA BOAT

New York, July 13.—Seventeen members of a stranded New York variety troupe who arrived here on a banana boat, declared that Venezuela is certainly a poor field for vaudeville. Although they offered Castro's countrymen the latest hits of the New York vaudeville, they could not come to terms with the yellow fever, the bubonic plague and the chronic excitement in that country. The company, which includes several women and children, booked at Caracas for eight weeks. After two weeks in the city, the bubonic plague broke out and they were driven from town. At La Guaira the American consul helped them get to Trinidad. There they tried to procure their fortunes, by a show under canvas, but reports of the plague drove away their audience. Finally, all but three decided to come home even if they had to sail with bananas and a sprinkling of tarantulas. They arrived here practically destitute.
