

Page 14, line 27.—After ("inspected") insert ("and every Inspector of Grain shall furnish to all applicants, samples of his standard on his being paid a reasonable price therefor.")

After some time the House was resumed, and

The Honorable Mr. *McDonald*, from the said Committee, reported that they had gone through the said Bill, and had directed him to report the same, with certain amendments.

And the said amendments being read a second time were agreed to.
