The Honorable Mr. Johnston, also by command of His Excellency, laid before the House the following ducuments from Captain Robb, of Her Majesty's Sloop Satellite, viz:—

Munger, of the United States, setting forth, that he had paid both the Parliamentary and Provincial Duties on a Camera Obscura or Magic Lanthorn, as well as on certain Diagrams or Views brought into the Province in the month of May last, for the purpose of assisting in the illustration of a course of Lectures delivered by him, and that at the close of the Lectures they were exported to the United States, and praying that the said Duties may be refunded to him; which he read.
