#### AMENDMENTS TO PROVIDE FOR ADDITIONAL JUDGES

Hon. L. T. Pennell (for the Minister of Justice) moved that the house go into committee of the whole at its next sitting to consider the following proposed resolution, which has been recommended to the house by His Excellency:

That it is expedient to introduce a measure to amend the Judges Act to provide salaries for two additional judges of the Supreme Court of Ontario, three additional judges of the Superior Court of Quebec, one additional judge of the Supreme Court of New Brunswick, one additional judge of the county court of Ontario, and one additional judge of the district court of Alberta.

# ADMIRALTY ACT

## AMENDMENTS RESPECTING DEPUTY JUDGES, ADMINISTRATION, ETC.

That it is expedient to introduce a measure to amend the Admiralty Act to authorize the appointment of not more than three deputy judges for each admiralty district and to provide for a certain change in the administration of the act.

# CANADIAN NATIONAL RAILWAYS

## AUTHORIZATION FOR CONSTRUCTION OF LINE IN NORTHWESTERN ONTARIO

Hon. J. W. Pickersgill (Minister of Transport) moved that the house go into committee of the whole at its next sitting to consider the following proposed resolution, which has been recommended to the house by His Excellency:

That it is expedient to introduce a measure to authorize and to provide for the construction of a line of railway in the province of Ontario by Canadian National Railway Company from the vicinity of Amesdale on the Redditt subdivision of the Canadian National Railway in a north northwesterly direction for a distance of approximately 68 miles to a point in the vicinity of Bruce Lake, in the district of Kenora, at a total estimated expenditure of \$11,100,000, not to be exceeded by more than 15 per cent.
