Inquiries of the Ministry

Mr. Trudeau: Yes, Mr. Speaker. Such meetings have already begun and I believe they are in progress at the present time. This is one of the reasons why the Minister of National Health and Welfare is not in the house just now. Premier Strom and myself are aware of the two ministers' meeting and may I repeat that it is going on right now.

Mr. André Fortin (Lotbinière): Mr. Speaker, in reference to the previous question and to a statement made yesterday by the premier of the province of Quebec, could the Prime Minister tell us whether the province of Quebec has been consulted about those negotiations with the provinces?

Mr. Trudeau: Mr. Speaker, there are no negotiations with the provinces. It is for those who wish to take advantage of the federal legislation to negotiate the terms with us as well as the date of its coming into force. On behalf of the government, I am willing to say publicly to Premier Bertrand that the more he will hasten to discuss with us the coming into operation of medicare in the province of Quebec, the more we will be pleased.

Mr. Fortin: Mr. Speaker, I would like to

ask a supplementary question.

Could the Prime Minister tell the house if the province of Quebec has officially refused to participate or if it is willing to discuss the matter with the federal government?

Mr. Trudeau: Mr. Speaker, I think it is important to reiterate to the house that before the legislation was passed, the province of Quebec had expressed through its government its intention to participate in the medicare plan. The federal government passed the law as a result of those consultations. Of course, the province is free to change its mind but the federal legislation remains in the statute books and in force.

BATH-MILLHAVEN FEDERAL PRISON COMPLEX
