DEATH OF MEMBER OF ARMED FORCES ON GUARD DUTY IN OTTAWA

WHEAT—NUMBER OF ACRES TO BE SEEDED IN 1971—LIFT PROGRAM

Right Hon. J. G. Diefenbaker (Prince Albert): Mr. Speaker, I have a question for the Minister of Agriculture having to do with the estimate he has been making recently as to the number of acres of wheat which should be seeded in 1971. Would he say what that estimate is and also whether, having regard to that estimate, he has concluded that the reasons for setting up the Lift program have not been justified by events and demands for wheat from all over the world?

Hon. H. A. Olson (Minister of Agriculture): No, Mr. Speaker, I would not agree with that conclusion. Canada will have at the end of this crop year sufficient quantities, notwithstanding the 50 per cent reduction under the Lift program, to meet all anticipated demands for Canadian wheat. What I and my colleague the Minister of Manpower and Immigration responsible for the Wheat Board have said is that it would appear at this time that up to about 20 million acres of wheat in 1971 would be appropriate.

Mr. Diefenbaker: Then may I ask the minister whether the estimate given by a prominent member of the grain trade and economist that on the basis of world demands almost 30 million acres will be required is not correct?

Mr. Olson: Mr. Speaker, if world demand appears to increase sufficiently between now and planting time in 1971, of course that will be taken into account in our information to farmers.
