GOVERNMENT POLICY RELATING TO BUTTER STORAGE

Question No. 2,648—Mr. Reynolds:

Are 70 million pounds of butter currently in storage in Canada and, if so, what is the government's policy in regard to disposing of same to the Canadian consumer?

Hon. E. F. Whelan (Minister of Agriculture): No; butter stocks which are required for domestic consumption are at the support price of 71 cents per pound.

STORAGE OF NATIONAL MUSEUM ARTIFACTS

Question No. 2,658—Mr. Forrestall:

1. With respect to answer to Question No. 2,207, which indicates that two of the 17 locations presently used to store historic artifacts will be upgraded this year, what steps will be taken to upgrade the remaining 15 storage facilities to prevent deterioration of artifacts set aside for future generations of Canadians?

2. Does the government consider that such storage and preservation facilities require upgrading to prevent serious losses due to poor or inadequate climatic control facilities in terms of humidity control, heat limitation and other factors essential to preserving articles of historical significance, broadly defined, for future generations of Canadians and, if not, what specific plans does the government have to make such provisions in the immediate future?

Hon. James Hugh Faulkner (Secretary of State): 1. I am informed by the National Museums of Canada that an invitation to tender has been called to upgrade the textile storage area at 1523 Laperriere Avenue, Ottawa. It is planned to expand the humidified storage area of historical artifacts.

2. The other fourteen storage locations are considered adequate for the type of artifacts stored, except as noted hereunder. Ashton Press Bldg., Bells Corners, Ontario: As soon as adequate storage facilities become available, artifacts of the Ethnology and Folklore Divisions will be moved. 7 Murray Street, Ottawa, Ontario: As soon as adequate storage facilities become available, artifacts of the Canadian War Museum will be moved.

Question No. 2,671—Mr. Cossitt:

What was the total amount of OFY funds allocated in 1972-73 to constituencies represented in the House of Commons by (a) Members of the Liberal Party (b) Members of the Progressive Conservative Party?

Hon. James Hugh Faulkner (Secretary of State): It is not possible to answer this question, since the allocation of the funds of the OFY programme is done within a framework of regions and sub-regions and not within the framework of electoral constituencies.
