**Hon. James Richardson (Minister of National Defence):** The DASH-7 does not meet the operational requirements established for the long range patrol aircraft, and is not being considered for that role. As an over the ocean capability is required the creation of additional bases is not a factor.

Lang (Minister of Justice):** This question requests information which, to the extent that it would be possible to identify, could be provided only by provincial law enforcement authorities. As the question is phrased, it would appear to be almost impossible to answer by any one jurisdiction since it could involve offences arising in many or all provinces of Canada as well as other coun-
