## MR. DELLA NOCE—ARTICLE PUBLISHED IN OTTAWA CITIZEN

Mr. Vincent Della Noce (Parliamentary Secretary to Secretary of State and Minister responsible for Multiculturalism): Mr. Speaker, I want to take the first opportunity available to me today to raise a question of privilege and clarify the false impression some may have got from the comments reported in the Ottawa Citizen of August 19, 1988.

Some may have got the impression that I witnessed certain questionable incidents. I wish to state categorically that I have no knowledge of any illegal or dishonest acts. The article gives an unfortunate interpretation of what I wanted to say about the need for politicians to maintain high moral standards.

If my comments resulted in some confusion, it is because I did not make myself understood clearly. The interview in question was conducted over the telephone, alternately in French and in English, and English is my third language. I deeply regret any inconvenience this may have caused or the negative impression it may have unfairly cast on others, including my colleagues in the House. For this reason, it was important that I clear up the matter in this House, out of respect for this institution and my colleagues. I ask them to accept my most sincere and profound apologies.

# CANADA-UNITED STATES FREE TRADE AGREEMENT IMPLEMENTATION ACT

#### MEASURE TO ENACT

The House resumed from Thursday, August 18, consideration of Bill C-130, an Act to implement the free trade agreement between Canada and the United States of America, as reported (with amendments) from a legislative committee.

"appointed by the Governor in Council subject to review and approval by a committee of the House of Commons."

That Bill C-130 be amended in Clause 21 by striking out line 14 at page 9 and substituting the following therefor:

"21.(1) The Governor in Council, subject to review and approval of a House of Commons committee, may"

He said: Mr. Speaker, over the weeks we have seen a process throughout this development and furthering of a trade deal with the United States which, as I said to the House on Thursday, was very much directed by the Cabinet, very much kept within the secrecy of Cabinet itself.
