9. Subsection (2) of section 59 of the said Act is repealed and the following substituted therefor:

Report.

"(2) The auditors shall make a report
(a) to the shareholders on the statement submitted to them as required by section 53; and

(b) to the Superintendent on the annual statement to be deposited in the Department in pursuance of this Act."

10. Paragraph (e) of subsection (2) of section 68 of the said Act is repealed and the following substituted 10 therefor:

"(e) the said by-law shall not increase the limit of the amount of money that may be borrowed by the company beyond, in the aggregate, <u>twelve and onehalf</u> times the amounts of the unimpaired <u>paid-up</u> 15 capital stock and reserve of the company."

11. Section 70 of the said Act is repealed and the following substituted therefor:

"70. (1) The company shall, on or before the 1st day of March in each year, prepare and deposit in the Department 20 a statement of the condition and affairs of the company as of the next preceding 31st day of December, showing the assets and liabilities of the company on the said 31st day of December and its income and expenditures during the year then ended, together with such other information as 25 the Minister may require.

(2) The statement required by subsection (1) shall be in such form as the Minister determines and shall be verified by oath of the president or a vice-president elected under subsection (1) of section 21 and of the manager or secretary 30 of the company."
