It is immaterial to us whether our Publications are ordered direct from us or through Agents in the Dominion. We are always pleased to fill Orders for the Publications at advertised rates, but we cannot assume charges for duty when such charges are levied.

In Sending Money through the mail, Security is best assured by using a Post-office Order, Express Money-Order, a Bank Check or Draft, or a Registered Letter.
