An unsuccessful candidate at g. e., 1886; re-elected March, 1887, to fill vacancy caused by resignation of Mr. Adams, the mem. elect. to run for the Commons. Re-elected 1890, 1892 and 1895. Apptd. Speaker of the Assem., 9 Mar., 1893, and a second time 13 Feb., 1896. A Liberal.—*Nelson, N.B.*

CARPENTER, ISAAC W. (*Queen's*).

A farmer. First returned to Ho. of Assem. at by-election held 1896 to fill vacancy caused by resignation of Hon. A. G. Blair, who was elected to the Commons.—*Carpenter, N.B.*

DAVIDSON, ALLAN A., Q.C. (*Northumberland*).

Called to the Bar, N.B., 1840. Apptd. Q.C., 11 Oct., 1880. Is a mem. of the Senate of the Univ. of N.B. An unsuccessful candidate for Northumberland in Ho. of Assem., N.B., at g. e., 1870. Sat. for that seat in that House from g. e., 1874, until 25 May, 1882; and in the Leg. Council from the latter date until the abolition of the Chamber. Returned to Ho. of Assem. at by-election held 1896, in consequence of the sitting member being elected to Ho. of Commons. A Conservative.—*Newcastle, N.B.*

DIBBLEE, J. T. ALLAN (*Carleton*).

Of U. E. Loyalist descent. B. at Woodstock, N.B., 20 Oct., 1856. Ed. at Carleton Co. Grammar School. M. Maria, dau. of John Ellegood of Dumfries, Co. of York. Is a mem. of the firm of W. F. Dibblee & Son, hardware merchants. Was a mem. of the Town Council for 5 years and Mayor of Woodstock, 1890 and 1891. First returned to Ho. of Assem. at g. e., 1892, and re-elected 1895. A Liberal-Conservative.—*Woodstock, N.B.*

DUNN, Hon. ALBERT T. (*St. John County*).

B. in St. John City in 1842. Is engaged in business as a pork packer and a farmer. Was Collector of Customs at Musquash for some years, but resigned 1892; also a mem. of the Municipal Council. First returned to Ho. of Assem. in 1892, and re-elected at last g. e. Became a mem. of the Ex. Council, 1892, without portfolio, and Surveyor General in July, 1896. A Liberal.—*Musquash.*
