An Act to vest in the Corporation of the City of Hamilton, the Water Works of that City.

W HEREAS the Corporation of the City of Hamilton have petitioned Preamble that the Water Works of the said City may be vested in the said Corporation, and it is expedient to comply with the prayer of such petition; Therefore Her Majesty, by and with the advice and consent 5 of the Legislative Council and Assembly of Canada, enacts as follows:

I. The Act of the Parliament of this Province, passed in the twentieth Acts 20 V., c. year of Her Majesty's reign, intituled "An Act for the construction 84 and 23 V., of Water Works in the City of Hamilton," and also another Act to ed. amend the same, passed in the twenty-third year of Her Majesty's 10 reign, intituled "An Act to amend an Act intituled An Act for the

- construction of Water Works in the City of Hamilton," shall be and the same are respectively hereby repealed : Provided always, that Proviso. neither such repeal nor anything herein contained shall affect, annul or make void, any matter or thing done or agreed to be done under the 15 said Acts, or relieve any parties from obligations incurred thereunder
- or whilst the same were in force.

II. All and singular the powers, privileges and authorities by the Powers gransaid Acts conferred, given and granted to the Water Commissioners of ted to the Water Comthe said City, shall (save only as they are varied by this Act), from and missioners by

- 20 after the passing hereof, be conferred upon, vested in and exercised by the said Acts, the Corporation of the City of Hamilton, which through its Council transferred to the Corporashall, in all respects and in every particular, occupy the place and tion of the position of the said Water Commissioners, and be liable for their City. engagements and contracts, and be entitled to the benefit of all con-
- 25 tracts, engagements and securities entered into with the said Commissioners, and be entitled to sue thereon in the Corporate name of the said City; and all property, real or personal, heretofore taken or held by or for the benefit of the said Commissioners, shall, from the passing of this Act, vest absolutely in the Corporation of the City of Hamilton;
- 30 And all and singular the enactments in relation to the said Water How the en-Works and the management thereof, in the said Acts contained, the actments of penalties thereby imposed, and the powers thereby granted to Justices shall apply. of the Peace, not inconsistent with this Act, are hereby re-enacted as fully as if the same had been repeated herein, save only as they are
