take the field for topographical work only. So far as I have known in Alberta, projections of base lines are carried out by survey parties in one year, and no subdivision takes place until there is a demand for settlement. That has been the procedure, and I did not make any inquiry whether a departure from it was to be made this year. I doubt, however, that there will be any departure from it. The director of surveys allocates the work where it is being asked for or necessity calls for it. That is the information I have received for a number of years in Alberta when I have made inquiries with respect to the matter of surveys, and while I did not make any inquiry this year, I imagine that is the reason that
