JUDGES ACT

FOR GRANTING ANNUITIES, ETC.

Hon. E. D. Fulton (Minister of Justice) moved that the house go into committee at the next sitting to consider the following resolution, which has been recommended to the house by His Excellency:

That it is expedient to introduce a measure to amend the Judges Act to provide salaries for four additional puisne judges of the superior court of Quebec; for the grant of annuities to judges upon attaining the age of 75 years; to remove anomalies in the present law relating to the grant of annuities under the act; and to alter the method of payment of travelling allowances to judges.
