2. Because of the small size of the maps, regularly scheduled routes only are shown. TransAir does not provide a direct service between Winnipeg and Churchill. However, this carrier does provide a service between these points via The Pas. The service between Winnipeg and The Pas is regularly scheduled and this route will be shown. TransAir provides a specific point service between The Pas and Churchill with some degree of regularity dependent on traffic volume. This route will not be shown.

Has the C.B.C. been requested to show a second time the National Film Board's film "Every Second Car" and its French translation "Une auto sur deux", concerning traffic security in automobile construction?

REPRESENTATIONS BY TORONTO BRANCH, NAVAL OFFICERS ASSOCIATION

- 1. Has the government received representations from the Toronto branch of the Naval Officers' Association of Canada, suggesting increased regulation of small boats?

2. Yes, rules proposed as follows: No debris, and Technical Surveys): 1. The next edition refuse, or human effluent shall be deposited of maps MCR 20 and 21 will show (a) the or pumped into any body of fresh water, or existence of a direct air route from Winnipeg into coastal waters, within a distance of twelve miles from land. All boats shall be equipped as required with proper containers for such sewage and waste, for subsequent deposit in authorized places ashore.

> No broken or empty glass or metal containers shall be deposited in any coastal or inland waters, or indiscriminately deposited on beaches or other shore areas.

> 3. A meeting was held between the Naval Officers Associations and the Department of Transport on February 15, 1966, to discuss the above representations. It was decided at that meeting that the representations be put forward for discussion at the next federalprovincial conference on small boats, invitations to which will be issued shortly.
