## INQUIRY AS TO FINAL DELIVERY QUOTAS

As of today at most delivery points in Saskatchewan there remain only 46 days on which elevators will be open to receive grain from the farmers, and as quotas at the present time range from 5 bushels to 10 bushels per specified acre, can the minister give the house any assurance that the Canadian Wheat Board will try to equalize these quotas in the remaining 46 days as the deliveries for this crop year will be closed off at the end of that period?

**Hon. Mitchell Sharp (Minister of Finance):** Mr. Speaker, I can certainly give the hon. member every assurance that the wheat board has that as its objective. I think the hon. member is aware, as I have been, of the remarkable progress that has been made in recent months in the equalization of quotas.
