Hon. Mitchell Sharp (Acting Prime Minister): I will take the representations of the hon. gentleman into account.

**Mr. Baldwin:** Would the Acting Prime Minister also consider the very alarming and serious increase in crime which is taking place and, together with his colleagues, give consideration to the appointment of either a parliamentary committee or the reference of the matter to a commission in concert with the provinces? I ask this question having in mind the responsibility of the government for social unrest arising out of the increasing unemployment.

# MOVING OF OTTAWA TELEPHONE RESERVATION SERVICE TO MONTREAL—GENERAL POLICY
