Mr. André Fortin (Lotbinière): I want to put a supplementary question, Mr. Speaker.

Mr. Lang: It depends, I suppose, on what is called an ordinary or extraordinary measure. Over a period of time the department did indicate until some months ago particular occupations or professions where there seemed to be a shortage or demand in Canada, and did this in the form of advertisements. Certainly in the case of doctors advertisements of this sort were run in some countries as part of our regular policy in relation to occupations in short supply. I know of no additional special measures.
