**Right Hon. P. E. Trudeau (Prime Minister)**: We have this under consideration, Mr. Speaker.

**Mr. Nystrom:** In view of the fact the Minister of Agriculture intimated in the House that as soon as price controls in the United States were lifted export controls in this country would be terminated, will the Prime Minister be making an announcement this week so that Canadian producers will not suffer?

Mr. Trudeau: That is exactly the matter I said was under consideration.

PROPOSED EXTENSION OF OIL PIPELINE TO MONTREAL— EFFECTS ON PROPOSED SUPERTANKER PORT AND PETROCHEMICAL INDUSTRY IN QUEBEC

**Mr. Gilles Caouette (Charlevoix):** Mr. Speaker, I should like to direct a question to the right hon. Prime Minister.

Considering that the answers concerning the construction of a pipeline for the province of Quebec seem much more unspecific and hesitant today than last week, is the right hon. Prime Minister aware that the representations made by Quebec are mostly due to the fact that the political program of the Quebec Liberal party was in fact based on the construction of a superport for tankers and the development of the petrochemical industry?

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, I do not agree that we are going back on what we said previously. If the hon. member will just look at my statement in last week's *Hansard*, he will note that at the very beginning of my announcement concerning the pipeline, I said that the government would soon need to have consultations about this matter with representatives from the provinces and the industry.
