MR. BEATTY—DELAY IN ANSWERING QUESTIONS

Mr. Perrin Beatty (Wellington-Grey-Dufferin-Waterloo): Mr. Speaker, I want to remind the parliamentary secretary again that many of us have had questions on the order paper extending back many months, and in some cases a matter of years. I wonder whether the parliamentary secretary might do the House the courtesy of saving if he does not intend to answer questions that have sat on the order paper for several months. Perhaps he could table in the House a list of those questions which the government has no intention of answering, so we could have some idea of what they are, and certainly if there is some justification for presenting such a list then I am sure those of us who are affected would be pleased to withdraw the questions. If that were done, at least we would have some indication of what the intentions of the government were, and we could pursue the government as to the reasons why it felt it was necessary to leave the questions on the order paper for a protracted period without giving any adequate explanation.
