CALL FOR INCREASE IN PRICE OF WHEAT—MOTION UNDER S.O. 43

With the substantial increase in the price of hard wheat and durum on the world market, and given the cost-price squeeze with which farmers are faced, I move, seconded by the hon. member for Swift Current-Maple Creek (Mr. Hamilton):

That the initial price of wheat be increased to \$6.25 a bushel on hard wheat and \$8 a bushel on durum wheat.

## **FISHERIES**

MEASURES TO CONSERVE SALMON STOCKS—MOTION UNDER

Mr. Thomas Siddon (Richmond-South Delta): Madam Speaker, I rise under the provisions of Standing Order 43 to propose a motion of urgent necessity. Whereas the Minister of Fisheries and Oceans (Mr. LeBlanc) has announced stringent new fishing regulations which affect commercial salmon fishermen on the west coast of Canada, yet for undisclosed reasons he has failed to place corresponding limitations on the large unlicensed charter boat operators who provide a fisherman's paradise for hundreds of well-to-do foreign tourists, allowing them to take hundreds of thousands of pounds of salmon from British Columbia waters each year, I move, seconded by the hon. member for Surrey-White Rock-North Delta (Mr. Friesen):

That, in the interest of conserving our fast-dwindling stocks of Pacific coast salmon and in the interest of equity, the Minister of Fisheries and Oceans be

required to implement measures immediately which will restrain the impact of recreational charter boat operations on salmon stocks; such measures to include a system of licensing, gear restrictions, seasonal closures and catch limits commensurate with the restrictions which have already been placed upon other persons who earn their income through fishing.
