### HUMAN RIGHTS

CALL FOR RELEASE OF ANATOLY SHCHARANSKY BY SOVIET AUTHORITIES—MOTION UNDER S.O. 43

Soviet Jewish dissident Anatoly Shcharansky has been unjustly held for over six months in solitary confinement and on low rations by the Soviet authorities in direct contravention of basic human rights and of Soviet obligations under the Helsinki Accord to respect the fundamental freedoms of conscience and religion. In view of this injustice and the plea of Mr. Shcharansky's wife that politicians in the west take up her husband's cause, I move, seconded by the hon. member for Lethbridge-Foothills (Mr. Thacker):

That this House call on the Soviet Union to live up to its obligation under the Helsinki Accord and immediately release Anatoly Shcharansky from detention.
