### DANGEROUS PRODUCTS

#### INJURIES CAUSED BY SOFT DRINK BOTTLES

**Mr. Svend J. Robinson (Burnaby):** Madam Speaker, in the absence of the Minister of Consumer and Corporate Affairs my question is directed to the Prime Minister. Four years ago the Government banned the use of 1.5 litre pop bottles after reports of widespread injuries, including several children who lost their eyes. Although the injury record of 750 mililitre bottles was just as bad, no similar action was taken whatsoever, with the result of some 300 injuries reported since then. Now that the Minister of Consumer and Corporate Affairs has met with the industry, what action will the Government finally take to ban the use of these dangerous bottles or, at the very least, to impose the same standards on these bottles as it earlier imposed on the 1.5 litre bottles?

**Mr. David Berger (Parliamentary Secretary to Minister of Consumer and Corporate Affairs):** Madam Speaker, the Hon. Member is aware that the Minister of Consumer and Corporate Affairs met with representatives of the industry on Friday. While I have not yet had the opportunity to speak with her, I am sure he is also aware of press reports stating that the industry is prepared to conduct an advertising campaign to make consumers aware of the dangers of these bottles. Furthermore, I think he will understand that there was tremendous concern over the previous ban in that it imposed tremendous costs on the industry. Apparently studies have indicated that the costs of such a ban on the 750 mililitre bottle would be prohibitive. I think he should take these arguments into consideration.

**Mr. Robinson (Burnaby):** The Minister admits that the bottles are a hazard, yet all she is doing is sweet-talking the industry into some sort of PR campaign.

#### REQUEST THAT BOTTLES BE PLASTIC COATED

**Mr. Svend J. Robinson (Burnaby):** Madam Speaker, in view of the fact that the industry has a plastic bottle coating plant in Ontario which has been sitting idle since January of this year, why does the Government not use its power effectively to ban these bottles or, at the very least, require that they be coated as the 1.5 litre bottles were coated, and stop mimicking the industry in claiming it costs too much? What is the cost of an eye or arm to a family whose child is hurt by these bottles?

**Mr. David Berger (Parliamentary Secretary to Minister of Consumer and Corporate Affairs):** Madam Speaker, I do not think it is correct to characterize the Minister's action as sweet-talking. However, we are accustomed to that kind of
