WATER POWER AND PULP MILLS.

Mr. John Boyd, the Government's road inspector for the Sault Ste. Marie district, is in town on official business. He, no doubt, drew the attention of the newspaper reporters. Mr. Boyd states that the pulp industry in that region is assuming large proportions. He says that on the Mississippi and the St. Lawrence Rivers there will be taken out this year over 50,000 cords of wood, which will be shipped to the United States. In addition to this a very large quantity will be cut to keep the pulp mill at the Soo running. This mill, he says, is in a very flourishing condition, the company operating it employing about 700 hands. This mill is adjacent to the water power that the Ontario Government offered for sale the other day. A condition of the sale was that the purchaser should develop 200 horse power, which is perhaps not one-twentieth of the power that is available. It is the same story all over Canada. We are playing into the hands of the Americans. The Americans are taking out our spruce in immense quantities, and converting it into pulp in the United States territory. We, on the other hand, remain content to make no more to keep the business in this country. There is an immense paper mill at Niagara Falls, New York, supplied with power by the Cataract Construction Company. No such mill exists on the Canadian side, nor could it exist there as yet, because Premier Hardy has sold the power franchise to an American company, who are interested in developing Niagara Falls and Buffalo, and who have signified their intention of developing the power on this side of the river. The policy of the Government is to give away the power. American centres are fully supplied.
