

## INSPECTION :

1. House in Committee to consider of bringing City of Winnipeg under Clause 2 of General Inspection Act, 1874; also of providing that Flinty Fife Wheat, when grown in Manitoba or N.W. Territories, may be inspected as higher than No. 2, 196. Resolution Reported; Agreed to; Bill presented, 197. See *infra*, 2.
2. Bill further to amend "The General Inspection Act, 1874" (Mr. Costigan); Ordered; Presented, 197. Read second time; Committed, 263. Reported, 264. Passed, 271. By the Senate, 388. R.A., 439. (46 Vic., c. 29.)
3. Petitions praying that such measures may be taken as will cause the Act to repeal certain provisions of the General Inspection Act of 1874, to be put into force by Proclamation, 225, 234.
